# TROPMAL IS COMPLE GONE

TENTH INTERNATIONAL CONGRESS ON TROPICAL MEDICINE AND MALARIA TO MEET IN MANILA

POSTAL COMMEMORATION OF NOVEMBER MEETING POSSIBLE

Thanks to R. Ward, Rockville, MD, and J. Moohr, Chcago, for furnishing the background material and illustrations for this article.

Invitations are our for the Tenth International Congress on Tropical Medicine and Malaria (TROPMAL) which will be held in Manila, Philippines, from November 9 to 15, 1980, at the Philippine International Convention Center.

Arrangements for stamps, or some method of philatelis recognition, have been stated to be underway by TROPMAL Secretary-General, Dr. Edito G. Garcia. The Congress has the full support of both the Philippine Ministry of Health and Ministry of Tourism.

Several Miasma Philatelist readers and the publication's editor have been corresponding with Dr. Garcia urging postal commemoration of the Tenth Contress. Readers wishing to express their support of this action should contact the Secretary-General at P.O. EA-460, Manila or at the cable address: TROPMAL, Manila.

The First International Congress of Malaria met in Rome, October 4-6, 1922 and the Second Congress met in Algiers, May 19-24, 1930. The Third Congress was held jointly with the Third International Congress of Tropical Medicine in Amsterdam, September 24-October 1, 1938. No postal commemoration of these meetings has been reported.

It was the original intent that the Fourth Congresses should be held five years after the meeting in Amsterdam, but the World War interfered and made it necessary to double the interval. The Fourth Congress was finally held May 10-18, 1948, in Washington, D.C. The Secretary-General of the Fourth Congress characterized that event as much needed after the ten year delay.

"The decade which had elapsed since the Amsterdam meeting and the many scientific discoveries of recent years accentuated the need for the Fourth Congresses and added greatly to the opportunity for making available a large accumulation of useful knowledge and at the same time stimulating international cooperation in the health field. Opportunities were open for making disease control in the tropics more effective and less expensive. New insecticides and new drugs needed more accurate evaluation and wider application. Moreover the scientists and administrators in the tropical medicine field were craving an opportunity to reestablish their contacts so as to plan more effective work in their own countries and better cooperation in an international drive on tropical disease. With accelerated dissemination of new knowledge through the Congresses and strenghened contral leadership through the World Health Organization and the Pan American Sanitary Bureau, there should be abundant opportunity to control disease wherever it is now entrenched." - Wilbur Sawyer, Secretary-General


Again, no examples of postal commemoration for this meeting have been seen by the author. Readers with examples are urged to forward photocopies to this publication.

# TENTH INTERNATIONAL CONGRESS ON TROPICAL MEDICINE AND MALARIA SCHEDULED (continued from page 1)

Istanbul was the site for the Fifth Congress in 1953. Exact dates were not found in the research and background information. Any assistance from readers on specifics for this meeting and possible philatelic items would be appreciated.

1958 was the year for the Sixth Congress, September 5-13, which was honored by stamps issued by Portugal (see page 1) and her colonies. These issues are noted by a number of album makers as forerunners of the 1962 WHO Anti-Malaria campaign issues. The Ayal album identifies them in error as issued for the Eighth Congress.



The Seventh Congress was held September 1-11, 1963 in Rio de Janeiro. Brazil honored this session with a special commemorative cachet cover and hand cancel. On the reverse of the cover appeared brief biographical notes on the five Brazilians illustrated (four by use of prior commemorative issues). These write-ups and the cover illustration appear in this issue's Personalities on Postage column.

Iran issued a set of two stamps (Scott #1480-1) and had a official philatelic sales booth in the Eighth Congress' registration area offering the stamps, covers and hand cancel service. The session was held in Teheran, September 7-15, 1968. Photo copies of the cover(s) and cancel are needed to complete the reference collection for Miasma Philatelist.






October 14-21, 1973, the Ninth Congress was held in Athens, Greece. And, now, the Tenth Congress is scheduled.

### PERSONALITIES ON

The illustrated cover and following personality profiles are from the collection of J. Moohr, Chicago, IL. Cover issued to honor the Seventh International Congress on Tropical Medicine and Malaria, Rio de Janeiro, Sept. 1-11, 1963. (see article on page 1)



Carlos Chagas (1879-1834) was born in the town of Oliveira, Minas Gerais; worked in the Institute Oswaldo Cruz of which he was director. In 1905 established the theory that 'malaria is a home acquired disease' and in 1909 discovered Chagas disease, its agent Trypanosoma Schisotrypanum cruzi, its vector Panstrongilus megistus and its animal reservoirs.

Oswald Cruz (1872-1917) was born in Sao Paulo. Was the founder and director of the Instituto Manguinfios (now Instituto Oswald Cruz). Pioneer of experimental medicine in Brazil and implanted successful sanitary measures, in the fight against yellow fever, malaria, plague and small pox. Won the first prize during the Berlin exhibit of 1907. (continued on page 5)

#7 Does anyone have a listing of all known cachets from the Philippines for their '62 WHO anti-malaria issues' first day covers and information on the designer(s)? I have 14 different and am quite impressed with the different ideas that were created and shown with these cachets. - J. Moohr, Chicago

John has sent in photo copies of the 14 different covers he has, send in photo copies of any you have and a master listing may be possible. Does anyone have information on the designer(s)??? With enough reader input this will make a feature for a future issue.

#8 What is the correct catalog and catalog number for the '62 anti-malaria overprints for South Kasai? They have been referenced both as Gibbons and Yvert #30-34 but appear in neither catalog. - E. Petscher, Massillon, OH

HELP!! Prior listings were for collector sales / want list. What is the correct -- if any -- identification?

#9 I "found" a Guinea 10¢ inverted overprint I never knew existed. Do all values exist with inverted overprints? - J. Moohr, Chicago

Assume reference is to Scott #B25 which esists with overprint in red, orange and black. Photo copies with notation on the color of inverted overprint will be added to the reference collection. Anyone else out there have other EFOs on Guinea B25-29?

Note: C. Clemmer, Chicago, has already furnished copies of his perforation and vignette errors for Guinea C29-31. There include missing verticle perforations, missing horizontal perforations, inverted vignette, plus left- and up-shift vignettes.

#10 For Laos' 1962 Scott lists #74-6 and a souvenir sheet as does Zinsmeister with #74-6 printed in sheets of 25. Newerla lists #74-6 perforate and imperforate plus souvenir sheets. The ATA's UN and Insects handbooks list only #74-6. What are the actual issues for Laos' participation in the 1962 WHO anti-malaria campaign?

To date the following items' photo copies (or actual) are in the reference collection: #74-6 perforate, matching first day covers, imperforate, mini-sheets of 4 and an imperforate souvenir sheet  $\{13mm \times 10mm\}$  with illustration of the three values plus inscription in Laotian and English. The souvenir sheet is reported by Zinsmeister to have been limited to 1,000 copies with 500 used for presentations and only 500 sold to the "public."

#11 Which stamps on fish, fowl and oil would properly represent those used in malaria control efforts? Has anyone studies this area or developed a listing of possible items for consideration? - E. James, London

Some readers have noted this sub-topic area as of interest and/or in their collection. Hope each of you will share your findings. Send identification and photocopies of fish, fowl (duck??) or oil topicals that you use/recommend as acceptable in a malaria thematic presentation.

#2 Additional information on Bhutan's unissued malaria eradication stamps: with thanks to E. Petscher, Massillon, OH., for furnishing a clipping from Linn's. This item announced Bhutan's joining the stamp issuing contries on May 16, 1962, with release of seven definitives (Scott #1-7) followed by two World Refugee Year commemoratives (Scott #8-9). A 1.30 nultrum malaria eradication commemorative -- with the same design as the 33 cheytrum value illustrated in this column (issue #2) -- was also reported as issued and was illustrated. Linn's source was noted as the Bhutan Trust Co., Ltd. of Nassau, Bahamas, via data originally published in Stamp Collecting and Philatelic Magazine, both British publications. Thus, to date, it appears that two values were planned but not issued due to the Buddha illustration and only one sheet of the 33 cheytrum value made its excape to the philatelic market.

Adolfo Lutz (1855-1940) was born in Rio de Janeiro and worked at the Instituto Bacteriologico de Sao Paulo and the Instituto Oswaldo Cruz. He was an outstanding clinician, epidemiologist, zoologist, pathologist and laboratory worker. Discovered the "juxta articularis nodules" (Lutz-Jeanselme nodules) and the South American plastomycosis (Lutz mycosis).

<u>Piraja da Silva</u> (1873-1962) was born in the town of Camamu, Bahia. He authored several research works in the old School of Medicine of Bahia; identified Schistosoma Mansoni in 1908 and won the Bernard Nocht Medal of the Institut fur Schiffs und Tropenhranheiten, Hamburg.

Gaspar Vianna (1885-1914) was born in the town of Belem, Paraguay. He did research work on tropical medicine and malaria at the Intitute Manguinhos for five years, studying the pathology of Chagas disease, identified the tissue forms of Trypanosoma S. Cruzi (Leishmania), described the Leishmania brasiliensis in 1911 and discovered the treatment of leishmaniosis by emetic tartar in 1912.

### ORGANIZATION FOR MALARIA TOPICAL AND THEMATIC COLLECTORS PROPOSED

With a world-wide range of collectors joining the readership of Miasma Philatelist the interest in this topical/thematic area is sufficient to consider a formal organization. This action is proposed to ensure continuity in production of this journal, development of a definative handbook/catalog and development of a master reference collection of both philatelic items and information related to Malaria.

In addition, a formal organization should be able to generate more awareness and further expand the number of collectors involved in exchange of information and collectables. To this end, a membership application and ballot for approval of the proposed constitution and by-laws of Malaria Philatelists International are included in this issue of Miasma Philatelist. Also included is a draft of the proposed framework for organization and operation of the group.

Readers who currently subscribe may transfer their subscription to dues. Charter memberships are offered at \$5 (US, Canada and Mexico), \$10 Foreign. The group will become official with the enrollment of at least 10 members including six willing to serve as officers. It is hoped that this minimum goal will be quickly reached so that 1981 will be the charter year.

The proposed constitution and by-laws appear on pages 11-14. The membership application and bollot for approval appear on pages 15.

# CARD ALSO ISSUED FOR 1960 EUROPEAN CONFERENCE IN PALERMO

A private postal card was also available as a philatelic moment of the March 31, 1960, European Conference of Malaria Eradication held in Palermo, Italy. Thanks to a reader who requested to remain anonomous for providing a photo copy which has been added to the reference collection.

The card's message portion is filled with the same multi-language special overprint as found on the cover illustrated in Vol. 1, Issue 2. The onl- difference being the control number identification "cartolina ufficiale" and "carte officielle". The Palermo special cancel and "official WHO" endorsement cancel shown on the cover also appear on the card.

The face of the card is an illustrated map of Sicily and its major tourist attrations. Background information is still needed on the conference itself and its philatelic items.





#### CONSTITUTION AND BY-LAWS

Malaria Philatelists International

- 1. Name: The name of this organization shall be Malaria Philatelists International.
- II. Purpose: The purpose of this organization shall be to:
  - A. further the collection and study of philatelic material relating to Malaria treatment, control, personalities, events, and its medical, socioeconomic, cultural and geographic history;
  - B. support and promote all local, national and international events and activities which advance interest and enhance the prestige of philately in general and topical or thematic philately in particular;
  - C. encourage the exhibition of Malaria related topical and thematic philatelic collections.

#### III. Organization:

- A. There shall be three classes of general membership all effective with the quarter in which the appropriate dues are paid.
  - Charter members who shall have made application to the temporary chairman and paid annual dues of \$5 (US, Canada, Mexico), \$10 (Foreign) on or before election of the charter officers.
  - Regular members who shall have made application to the Secretary-Treasurer and paid the annual dues as established by the Board of Directors.
  - 3. Sustaining members who shall be members contributing \$1 or more for the organization's sustaining fund with their dues payment.
- B. There shall be one class of membership effective for annual periods starting with January 1 or the member's current expiration date.
  - Honorary members who, for service to this organization, are elected by the Board of Directors. Honorary members shall have all rights of Regular members and shall pay no dues for the annual period that follows their election.
- C. Membership shall be open to individuals interested in Malaria philately. Commercial or corporate memberships, in the name of an organization, shall not be allowed.
- D. The Board of Directors of Malaria Philatelists International shall be composed of a President, Vice President, Secretary-Treasurer and three Directors.



III. Organization: (continued)

D.

- The President shall preside at all meetings of the Board and membership; represent the organization at (or appoint representative to) gatherings of other philatelic organizations; and appoint all committees, chairpersons and non-elective officers established by vote of the Board of Directors.
- The Vice President shall serve as adisor to the President; perform the Presidential responsibilities when the President is absent or unable to serve; be ex-officio member of all appointed committees; and be chairman of the standing committees on publications and exhibitions.
- 3. The Secretary-Treasurer shall keep all records of the membership, meetings of the organization and its Board of Directors; receive, preserve and disburse all funds of the organization; manage the general paperwork of the organization; and serve as chairman of the standing committees on membership and finance.
- 4. The Directors shall represent three geographic areas of the membership (other than the one represented by the Secretary-Treasurer) from the following: Eastern North America, Western North America, Central America, South America, Europe, Africa, Australia-Pacific, Asia.
- 5. All necessary business of the organization not specified as duties of individual officers or standing committees shall be conducted by the Board of Directors with each member having one vote.
- E. There shall be four standing committees to assist the Board of Directors in operation of the organization.
  - 1. A publications committee shall be responsible for quarterly publication of a professional Malaria philatelic journal for the membership; development and maintenance of a handbook/catalog of Malaria philatelic material; and development, maintenance and preservation of a supporting reference collection of actual copies and/or graphic reproductions of Malaria philatelic items and research papers.
  - 2. An exhibitions committee shall be responsible for maintaining records on future opportunities for topical or thematic collections to be exhibited; advance publication on these events in the journal of the organization or be special notices; reporting on the results of all reported member entries; and promotion of and education on topical and thematic exhibiting to the membership.



#### III. Organization: (continued)

E.

- 3. A membership committee shall be responsible for promotion of the organization, its goals and benefits to non-members; establishment and operation of incentive programs to retain current members and have them solicit new members; hear all proposals for expulsion and recommend action to the Board of Directors; and educating members about the code of philatelic ethics established or adopted by the organization.
- 4. A finance committee shall be responsible for reviewing and reporting to the membership each December on their audit of the fiscal records of the organization; recommending, based on their audit, any revision to the annual dues to be established by the Board of Directors; and determination of the disposition of the sustaining fund maintained by the Secretary-Treasurer with concurrance and approval of the Board.

#### IV. Operation:

- A. The organization shall operate only for non-profit purposes and no net earnings shall benefit any individual excepting where the Board of Directors have adopted, and notified all members via publication in the official journal, arrangements to pay for services of an individual by means of wages, commissions, etc.
- B. Elections for officers and directors shall be held every even numbered year in the last quarter with those individuals elected taking office on January 1 of the following year, except the charter election may be held in any year.
  - All officers are limited to two consecutive terms in the same office and a maximum of four consecutive terms as an officer. Directors are not so limited.
  - Initially the temporary chairman, and subsequently an appointed nominating committee, shall propose candidates for positions to be filled, verify their willingness to serve, and present ballots to all active members no later than September 1.
  - 3. Ballots returned, as noted on the ballot, by December 1, shall determine the election. Candidates receiving the largest number of votes shall be elected. Ties shall be broken by a flip of a coin witnessed by two members.
- C. An annual membership meeting shall be held, if possible, in conjunction with a major philatelic event. Additional general or regional meetings of the membership may be held as deemed appropriate by the Board of Directors. All such meetings shall be announced to the full membership at least thirty days in advance.



#### IV. Operation: (continued)

- D. The affairs of the Board of Directors and all committees may be held by mail or at formal meetings.
  - The President shall call and preside over all meetings of the Board or estabish the mail ballot agenda.
  - The Secretary-Treasurer shall notify all Board members of agenda items for discussion or balloting at least ten days prior to any meeting or mail ballot.
  - .3. Four members of the Board shall represent a quorum and may be represented individually or by proxy given to another member of the Board. A simple majority of Board members voting shall carry an issue.
  - 4. Where the presence of four Board members in fact or via proxy can not be achieved, all issues to be considered must be submitted to the general membership for mail balloting. A simple majority of the members voting shall carry an issue.
- E. This organization shall affiliate itself wherever possible with appropriate related broader-base philatelic organizations. Such affiliation shall be noted as subparagraphs below when achieved and be stated in each issue of the organization's journal.

- V. Adoption and modification of this instrument shall be by the proposed and actual membership respectively.
  - A. This constitution and by-laws shall become in effect upon acceptance by the act of membership application and payment of dues by no less than ten members of which six have indicated willingness to serve as officers.
  - B. Proposed revisions or additions to this instrument shall be presented in the organization's journal with ballot forms upon recommendation by two members of the Board or any group of members representing 10% of the current active membership as certified by the Secretary-Treasurer. Such recommendation shall be deemed made if presented in writing to the Vice President, and shall be deemed accepted if approved by 2/3 of the ballots cast as long as a simple majority of the current active membership did vote.



This constitution and by-laws for an organization to be known as Malaria Philatelists International is transmitted to the current readers of Miasma Philatelist, being a known group of philatelic collectors with interest in the topical and thematic area to be serviced by the organization, by the Editor acting as temporary chairman for the proposed organization.
